TERMS AND CONDITIONS

- 1. **Due Date:** The quotation complete in all respect, duly sealed & super scribed should be submitted to this office on or before **Dt. 13.04.2023** up to **17:00** Hrs Positively.
- 2. **Enquiry Fees:** The vendor has to pay Enquiry Fees of **Rs. 100/-** in cash to this office before submission of quotation. The copy of paid Money Receipt for same should be attached with the quotation.
- 3. Scope of work: As detailed in schedule' A' Limited to Rs. 4,60,324.56/-(including GST)
- 4. **Quoted Rates**: The quoted rates should include the cost of taxes. The Taxes will be clearly mentioned, & if the Taxes are not clearly mention, then it will be considered as Inclusive of all taxes.
- 5. **Security Deposit**: The successful contractor shall have to deposit the security deposit of 5% of contract value towards security deposit in this office by Cash/DD/B.G./FDR within 15 days before commencement of the work. The same shall be refunded to you after satisfactorily completion of work after 12 months and as per availability of funds.
- 6. Validity of Offer: The offer should be valid for our acceptance for a period of 60 days from the due date of same.

- 11. **Execution & Supervision of work:-** The work shall be supervised by the Add. Executive Engineer (M), appointed by under signed and it should carry out to the satisfaction of Engineer, in charge. In case of any dispute, decision of undersigned shall be final and binding on the contractor.
- 12. Bills:- All the payments will be made by Account Payee Cheques only. The agency will have to submit the original bills in three copies for above works in the name of undersigned to the office of Executive Engineer, 400 kV RS Dn, Deepnagar, BSL-II. The Engineer incharge, Addl. E.E.(Maint.) will verify & records the bills in SES & after verification, the original bills along with SES, NOC, work completion certificate along with before and after photos of work done should be given, and will be sent to the Executive Engineer, 400 kV RS Dn, Deepnagar, BSL-II for further auditing & passing the bills. The Executive Engineer, 400 kV RS Dn, Deepnagar, BSL-II shall make necessary arrangement for effecting of the payment at Division level subject to the availability of funds.
- 13. **Payment Schedule:-** 100% Payment will be done after successful completion of work & against the submission of bill & subject to the availability of the funds.
- 14. **Income Tax, TDS & Labour Cess:-** The Income Tax, GST TDS & Labour Cess as per rules will be deducted from your bills and certificate for the same will be issued.
