**Terms & Condition**

- 1) Security Deposit: - You will have to pay Security Deposit 10% of order value before issue of work order.
- 2) Material check : - The supply of the material i.e WTI will be checked by the 220kV Mudshingi S/s Incharge.
- 3) Scope of work – The work includes as per schedule A & as per the instruction of concern substation In-charge. Transportation of material will be at your cost only. Delivery challan should be submitted at 220kV Mudshingi S/s.
- 4) Working period : The work should be completed within 1 month from the date of issue of work order.
- 5) Penalty: - In case of work is not completed as per schedule in specified time i.e within one month from the Dt of issue of work order, the contractor shall be liable to pay penalty @ 1 % per week on work order amount subject to maximum 10% of order value. Further, if any defect observed in the supplied material then it should be replaced within 7 days from the Dt. Of handing over, otherwise 1% penalty on work order amount will be implemented and same will be deducted from security deposit.
- 6) You shall abide with all Govt. rules, regulations, status for this work including workman compensation act etc.
- 7) Quality of Materials: - The materials used for this work should be of best quality and confirming to the IS standards. The bad quality material will be rejected. Material will be approved by the 220kV Mudshingi S/s Incharge
- 8) Accidents:-Any accident to your labour during the execution of work, any loss/ damage to MSETCL property will be on your account and you will have to make it good at your cost.
- 9) **Risk & Cost:-** In case you fail to complete the work fully or partly, the balance work will be completed from other agency and difference in cost will be recovered from your bill and security deposit in this case will be forfeited to Company.
- 10) Insurance:-The Insurance of your labour at your cost only. If fail the compensation / Claim arrears will be at your risk
- 11) MSETCL will not provide accommodation to your technicians / Supervisor, Labour, The transportation of materials / labours will have to be done at your cost.
- 12) Payment/Bills:: The bills for the work as per Schedule 'A' should be submitted in 3 copies, to Additional Executive Engineer, 220kV Mudshingi S/s along with delivery challan and invoice. Necessary SAP entries will be done by concern substation incharge.

- 13) **GUARANTEE:** - The materials should be guaranteed against manufacturing defects, for a period of 1 year from date of supply of the material. Within guarantee period if any defect observed it should be replaced free of cost within 7 days from the Dt. Of intimation.
- 14) All disputes / differences arising under/ out of or in connection with the contract shall be subject to the exclusive jurisdiction of Kolhapur court only.
- 15) The MSETCL Terms and Conditions of work contract are applicable for this work.
- 16) Monitoring of Order amount:- You should have to monitor work order amount. If the work exceeds beyond work order amount, excess amount will not be paid at any cost.
- 17) Undersigned reserve the right to cancel order in part or full at any time without giving in notice.

6	<u>EMD payment</u> Firm / Bidder has to pay EMD irrespective of SRM system asks for the same, also details of EMD is below mentioned.

**Firm / Bidder has to pay EMD irrespective of SRM system asks for the same or not in following cases:**

- 1) a) The Micro and small enterprise (Only manufacturing and service enterprise) as defined in MSMED Act, 2006 are exempted from paying EMD and tender fees. The Udyog Aadhar Memorandum and Udyog Aadhar Registration certificate submitted by said enterprises should indicate the same material / service as required against the tender floated.
- 2) The Bidder has to pay EMD and tender fees in following cases:
  - a) If the micro /small enterprise registration certificate does not indicate the relevant classification code covering material / service as required against the tender floated.
  - b) If investment in the plant and machinery or equipment exceeds the threshold limit indicated in the MSMED Act, 2006 (at present the threshold prescribed limit being for

- 3) In case of works contract, if the Micro – small enterprise submits that the enterprise shall supply all the materials of intended works contract, manufactured from its own unit, then it shall be eligible for exemption of payment of EMD & tender fees to MSETCL. However, an undertaking duly notarized from micro and small Enterprise to this effect is to be submitted along with bid.
- 4) The works contractor except as stated above and Traders are excluded from the benefits of EMD and Tender fees, hence shall be required to pay EMD or Tender fees while participating for e-tender process at MSETCL.
- 5) The registration certificate as submitted by micro & small enterprise should be valid on the date of submission of bid and the validity of the same should be certified by the Chartered Accountants in practice.

\*If required EMD is not paid by the bidder, offer submitted will be liable for rejection\*.

**Note:- 1) Right to call deviation for above documents will be reserved with the Executive Engineer, rejection of offer due to insufficient documents will sole responsibility of bidder.**
