 - Certificate of vehicle Registration,
 - Certificate of Vehicle fitness
 - Insurance Policy Certificate of vehicle
 - Certificate of Tourist Permit
 - Xerox copy of Driving license
 - PAN Card
 - Receipt of Road Tax & Professional Tax
 - Certificate of Valid shop act & establishment registration or NOC of Grampanchayat as applicable.
 - GST Registration no. (If applicable)
 - Valid PUC copy
- If validity of any license/certificate expires during order period, you will have to renew the same & submit the copy to this office.
- Quotations with incomplete details submitted without sealing or superscribing not submitted in prescribed format etc are liable to reject. Offer on fax or e-mail will not be accepted. This office will not be responsible for delay in postal transit. The agency should not submit 'conditional quotation'. Such conditional offer shall be liable for rejection.
- The rates should be quoted on firm quotation basis. The rates should be inclusive of drivers salary, fuel cost. Taxes should be quoted separately.
- The normal duty hours will be from 08:00 to 18:00 hrs. on every working day & you will have to make vehicle available at **Substation Maintenance Unit Ganeshkhind** as per the instructions of Addl. Executive Engineer, Substation Maintenance Unit Ganeshkhind, Pune. The running of hired vehicle will be the area of operation under Substation Maintenance Unit Ganeshkhind, Pune.
- Driver:** Vehicle will be driven by your driver who shall be well behaved, neatly dressed with good habits. He should scrupulously (carefully) follow all rules & regulation of RTO & traffic police. He must possess valid driving license.

7. The contract amount will be limited to **Rs. 5,50,000/-** (inclusive of GST) including drivers salary & fuel charges and period will 11months or exhaust of order amount whichever is earlier. You have to pay 5% of work order value as SD.
8. The vehicle should be registered on or later 2018 (submit document proof) preference shall be given to such vehicle.
9. The right to place an order for part or to cancel any or all quotations without assigning any reasons is reserved with this office.
10. The average consumption of the vehicle given on hire basis should be 10 km/litre minimum irrespective of actual average of the vehicle.
