**TERMS AND CONDITIONS:-****Submission of bid**

Two bid systems should be followed for submitting the offer. Uploading of required documents shall be done on MSETCL's SRM E-tender website.

**A. Techno –Commercial bid:**

This should contain following documents certificates (all self attested copies) as a proof of qualifying pre-requisites, brochures, attested certificates etc.

- Valid Electrical Contractor License.
- Valid Goods & Service Tax (GST) registration certificate.
- Valid Shop Act Registration/ Gram Panchayat NOC.
- Valid work compensation /insurance policy.
- Copy of PAN card & last 03 (Three) years IT returns.
- Work order copy & experience certificate of Circuit Breaker overhauling work (132kV & above voltage level) executed in MSETCL/ any transmission utility / Govt. organization (not below the rank of Executive Engineer)

**If validity of any license/certificate expires during order period, you will have to renew the same & submit the copy to this office. Payment will be affected for valid period only.**

**B. Commercial bid: -** Bidder should upload the digitally signed price bid under commercial bid online.

- Techno-commercial bid will be opened online for all received bids. After verifying the all documents /certificates submitted in techno commercial bid for prequalification as mentioned above, if it is found that, the Tenderer fulfills the desired prerequisites; the price bid will be opened online. If the same is not found to

be meeting the prerequisite, the commercial bid shall not be opened. Tenders with incomplete details or not submitted in prescribed tender form etc. are liable to reject.

- This office reserves all the rights to reject any or all tenders without assigning any reasons thereof.
- The technical documents should be uploaded in the technical bid & commercial documents /offer/price bid should be uploaded separately, in case both technical & commercial bid are uploaded in one file wrongly, the offer will be rejected.
- The E.M.D. and Tender Fees is to be paid online only through SRM E-Tenders (New) Portal within the tender sale period.

**“Note: Earnest money deposited will be refunded online through SRM System after approval from competent Authority. EMD will be credited to the bank account maintained by bidder in vendor Profile in SRM system. Bidders are requested to ensure that the bank details i.e. Account No., IFSC Code, Account Holder Name, Bank Name, Bank Address are correctly maintained in SRM System and update the same, if required.**

**It may be noted that:**

- 1) In case bank details are not maintained by the bidders in their SRM Vendor profile, EMD will not be refunded online and MSETCL will not be responsible for the delay.
- 2) MSETCL will not be responsible for any financial implications in case incorrect bank details are maintained by the bidders as it is the sole liability of the bidder to maintain correct bank details to facilitate online refund of EMD.”

- 2) The rates quoted by you should be exclusive of GST in “Schedule- A”. GST will be paid extra as per prevailing rules.
- 3) The work should be completed within given outage period. The necessary arrangement for outage will be done by respective S/Stn incharge.
- 4) The work carried out should be as per the standard practices of MSETCL & material required for this work should be taken from MSETCL approved vendors/ CB manufacturer only.
- 5) **SCOPE OF WORK:**
  - a. As per Schedule “A”.
  - b. The contractor shall be fully responsible for compliance of all statutory obligations under the Factory Act 1948, Contract Labour (Regulation and Abolition) Act 1970, Maharashtra Labour Contract Regulation & Abolition Act, 1971, Minimum Wages Act, Provident Fund Act and ESIC Act / Workman Compensation Act 1926, Payment of Wages Act in respect of the Staffs deployed. The rules and regulation of the Contract Labour Act shall be binding on the contractor.
  - c. The Owner will not be responsible for violation of these statutory rules and regulations by the contractor.
  - d. It shall be the sole responsibility of the contractor to observe all the relevant acts and regulations along with amendments thereto framed by the Government from time to time. The Owner shall not be responsible for violation of any of the above stated regulations / Acts etc. by the contractor.
- 6) You will have to arrange all tools, plants, manpower etc. to carry out the work at your own cost.
- 7) You will have to provide all safety measures to your staffs while executing the work in sub-station.
- 8) **GUARANTEE:** - You should give guarantee of the work done against this work order, good quality & workmanship must be guaranteed for best performance at least for 12months from the date of work done.
- 9) The payment shall be made only after satisfactory completion of work as certified by the concern Engineer In-charge by Cheque only.
- 10) **SECURITY DEPOSIT:**
  - a. The successful Contractor(s) will have to submit **Security Deposit** at the rate of 5% of the value of the order, by cash /Demand Draft / Fixed Deposit / Bank Guarantee at the office of the Executive Engineer, EHV O&M Division Babhaleshwar, within 07 (Seven) days from the date of receipt of letter of intimation. The detail order will be issued only after the payment of security deposit.
  - b. The Bank Guarantee shall be on a Scheduled Bank / Nationalized Bank and it shall be valid until 90 days after the contract period and the claim period shall be for further 90 days.

- c. If the successful Contractor fails to submit Security Deposit within the stipulated period, it will be presumed that the Contractor is not interested in execution of the contract and the work contract will be issued to other agency (i.e.). The decision of E-enquiry accepting authority i.e. the Executive Engineer, EHV O&M Division Babhaleshwar shall be final and remain binding on the Contractor(s).
- d. No interest will be paid on the Security Deposit and the Security Deposit will be refunded after satisfactory execution of works / guarantee period, whichever is later.

**11) AGREEMENT & STAMP DUTY:-**

- a. The successful Contractor has to execute an Agreement with The Executive Engineer, EHV (O&M) Division, MSETCL; BABHLESHWAR within 7 days after receipt of letter of intimation, the work order will be only issued after executing the Agreement & submission of security deposit @ 5% to this office
- b. The successful Contractor shall submit an Agreement Bond on non-judicial stamp paper as per Mumbai Stamp Duty Act 1958, clause No. 34. The expenses towards the stamp paper and preparation of Agreement Bond will be on the part of the contractor.

**12)** The undersigned reserves the right to reject any or all the bids without assigning any reason whatsoever.

**13)** If the work is not carried out within the stipulated time / period, penalty @ ½% per week will be recovered from the contractor's bill subject to 10% maximum.

**14) LIABILITY OF ACCIDENT / LOSS:** The contractor will be responsible for any accident to any of his personnel or loss to him during the work. The responsibility of the insurance towards the same shall be with the contractor. The compensation to the contractor's personnel will be the responsibility of the contractor.

**15) EXCEEDING THE CONTRACT VALUE:** The contractor will have to watch and ensure that the total value of work carried out by him does not exceed the contract value. If the work / value of contract is likely to be exceeded the same should be brought to the notice of the undersigned in writing. If the value of the total work exceeds the order value in that case the contractor is not permitted to execute the work without prior permission from the undersigned.

**16) DAMAGE TO PERSONS AND PROPERTY: -** Contractor will indemnify the MSETCL against any losses and claims regarding any injuries or damage to any person, material or physically damage any property whatsoever which may arise out of or in consequence of the execution of work. During execution of work any damage/loss to Transmission Company's property occurs will be recovered from your bill.

**17) SUBLETTING OF THE CONTRACT:**

- a. The contractor will not sublet / transfer / assign the contract as a whole or any part or any operation thereof to any other party.
- b. In case the contractor sublets/ transfers / assigns the contract as a whole or any part it or any operation thereof to any other party, it will be treated as breach of contract and the contract will be terminated at contractor's risk and cost.

**18) INSURANCE:** It is responsibility of contractor to take all necessary insurance of material/ equipment/ labour for execution of work for all his liabilities direct/ indirect for all his liabilities direct/ indirect from Director of Insurance only (Director of Insurance, Room No 264, 1st Floor, Mhada Grah Nirmaan Bhavan, Bandra East, Mumbai - 400051, Opposite Kala Nagar). As per the directives of Corporate office letter no. 8450 Dtd.30.11.2022, it is to be noted that in case the aforesaid directives are not followed by the contractor, the concerned authority of MSETCL shall recover 1% of contract value and deposit same with Director of Insurance, Govt. of Maharashtra, Mumbai by cheque/DD with complete details of contract.

**19)** Quantities shown are tentative & subject to variation on either side.

**20) VALIDITY OF ORDER:** The order will be valid for until exhausting of the order amount.

**21)** Income Tax & statutory taxes as applicable shall be deducted from your bills as per prevailing Government rules.

**22) CONTRACTOR'S DEFAULT:**

- a. In case you fail to complete work fully OR partially, the security deposit will be revoked by MSETCL. In this case the balance work will be got done from other agency may be at higher rates and the difference in cost will be recovered from the contractor's bills.
- b. In case of any loss / damage to the Owner's asset /material, it will be the sole responsibility of the contractor to lodge the complaint in writing to the nearest police station under intimation to this office or to In-charge/ designated officer.
- c. If there happens any loss of goods or damage to valuable material in the premises on account of negligence of the Staff, the cost of loss / damage shall be recovered from the contractor.
- 23) **SUSPENSION / HOLDING OF WORK:** If the work has to be suspended due to any reason i.e. stay order from court of law, legal held up from any other Agency, shut down etc. the MSETCL shall not pay any compensation / damage to the contractor towards item like idle labour, etc. In such cases the contractor is not liable for claiming extra payment.
- 24) **DEDUCTION:** Any Amount which become payable by the contractor to the MSETCL under particular contract will be deducted by the Owner from any amount due or becoming due to him to the contract under the same or any other contract.
- 25) **SAVE AND EXCEPT:** Amount due to account of damage or compensation for default or breach of contract by the contractor in which case instead of deduction of the same amount shall be retained and the Owner shall have the right on amount so retained or withheld.
- 26) **TERMINATION OF CONTRACT:** The Undersigned reserve the right to terminate the contract at any stage without assigning any reasons thereof.
- 27) **GENERAL:** The Contractor are also deemed to be fully aware of the company's general conditions of contract for work, supply of equipment/material and any ignorance of any of the condition will not exempt you from liability to abide by the same.
- 28) Validity period of offer should not less than 90 days.
- 29) **JURISDICTION:** All disputes or difference arising out of and in connection with the contract shall be subject to the exclusive jurisdiction of Ahmednagar Court only.
