

- 2. SCOPE OF WORK: As detailed in enclosed schedule.
- **3. QUOTED RATES**: The rates quoted shall be inclusive of cost of material/labor charges, transportation, material & requisite T&P required for execution of work, lodging boarding, incidental charges, etc. (whichever is applicable). The condition for taxes shall be mentioned clearly in price bid. If nothing is mentioned regarding taxes, it will be treated as rates quoted are inclusive of all taxes.

- **4. COMPLETION TIME:** The successful bidder should supply the material within 30 Days of LOI/order receipt.
- **5. PAYMENT**: On completion of the job, the duly certified bill should be submitted to the Executive Engineer. The payment will be effected by this office within a reasonable time as per actual work done.
