1. Rates should stand firm at least for the period mentioned above .The vehicle shall be in good condition. The tyres should not be worn out.
2. GST as applicable will be extra.
3. **Attested Xerox copies of the vehicle documents such as RC Book, TC book, Tax paid Certificate, insurance certificate, Fitness certificate, PUC certificate, taxi permit etc will have to be submitted to the office along with the quotation submitted.**
4. Please mention the consumption average of the vehicle clearly km/lit of diesel.
5. The general working time is from 9.00 am to 9.00 pm. This time may vary as per the working conditions and as directed by the authority.
6. The vehicle will be required for almost all working days as per calendar month and as and when required in emergency as well as on holiday also.

7. No overtime will be paid for excess working hours, if utilized for any day and no halting charges will be paid.
8. The vehicle will have to be stationed at the place indicated by the Add.Executive Engineer, **PID Unit, Amravati.**
9. Only Diesel will be provided by the Company and Engine oil /lubricants or other items will not be provided by the Company. The manufacturing of vehicle should not be before the year of April-2015.
10. The cost on account of maintenance/ repairs, driver wages, allowances and vehicle taxes etc. if any shall have to be borne by the Agency.
