The Clause No. 1.0 Price of **Section III of the tender document is hereby amended as under:**

The tenderer shall visit the site of installation i.e. MSLDC, Airoli for joint survey before submission of bid and shall accordingly bid for all items and services as per complete scope of work detailed in technical specification. **The prices shall be quoted by the bidder at Item Level ‘Conditions’ of the RFx and the duly filled price bid format Annexure B indicating all components of F.O.R.D Price quoted i.e. Ex-works, Freight, Insurance, Packing & Forwarding, GST applicable, etc. shall invariably be uploaded under attachments ‘Notes/ Supporting Price Bid Documents’ of the RFx. The offers in which the price bids are not submitted as stated above shall be liable for rejection.**”*

The prescribed price bid format Annexure B is hereby uploaded in the RFx. Further, the due dates of submission and opening of Tender are hereby modified as under:
