Please refer e-Tender No. SP/T-0701/0223 [RFx. No. 7000026144], advertised for Hiring of Agency for Non-Comprehensive Annual Maintenance Contract (AMC) for computer Systems (Desktop/Laptop), Network & Network Peripherals, Printers, Scanners, Computer Peripherals at various locations under MSETCL Corporate office for period of One [1] year.

**The Clause No. 7 EARNEST MONEY DEPOSIT (EMD) of Section I of Tender Document hereby stands amended as under:**

**7 EARNEST MONEY DEPOSIT (EMD):**

- 7.1** The tenderers shall pay the Earnest Money Deposit of Rs. 24,591.18 /- (@1% of estimated value) of the tender as indicated in RFx advertised unless the tenderer is exempted on account of having a valid permanent Bank Guarantee of Rs. 20 Lakhs (Rs. Twenty Lakhs) for LSI and Trading units or Rs.5 Lakhs (Rs. Five Lakhs) for SSI/ NSIC units with the Central Purchase Agency of the Purchaser or having valid registration with SSI/ MSME/ NSIC for the tendered service. The same shall be paid Online by the bidder before submission of their response on SRM e-tendering. No interest shall be paid on the Earnest Money Deposit.
- 7.2** For tenderers exempted from payment of EMD against their registration with MSME/SSI/NSIC, the exemption shall only be applicable to the item(s)/ service(s) indicated in the registration certificate issued by the concerned authority. Note that, if the tendered item(s) is not maintained in the above list of item(s)/ service(s), the bidder shall be liable to pay the Earnest Money Deposit through “EMD Payment” link provided on SRM e-tendering before submission of their response. Failure to make payment of Earnest Money Deposit shall result in disqualification and rejection of offer thereof. The bidder shall submit the MSME/SSI/NSIC certificate alongwith their offer towards proof of exemption in payment of EMD.

- 7.3 Earnest Money Deposit shall stand forfeited in the event of the following:
- a) Offer is withdrawn after opening of the technical bid
  - b) Offer is withdrawn during validity period
  - c) Offer is withdrawn before the Tenderer receives formal intimation of decision taken in this regard to this tender
  - d) Tenderer fails to pay Security Deposit against this order.
  - e) Tenderer fails to execute the Stamp Agreement after receipt of Order
  - f) Tenderer fails to accept L.O.I. (Letter of Intent)
- 7.4 In such events Purchaser shall be entitled to recover the amount of EMD paid or by resorting to any other remedy available under the law.
- 7.5 If the successful tenderer upon award of the contract fails to pay the security deposit of the order / contract, then the Purchaser without prejudice reserves the right to recover damages, if any.

All participant bidders are requested to take note of the above and submit their bids accordingly. All other terms and conditions of the Tender specifications remain unchanged.
