Manufactures shall have Routine Test Facilities (As per IS 27015 and IS.IEC: 60044-1) and Test Facility for Temperature Rise Test, Lightning Impulse Test and Composite Error Test (for Ensuring Low Reluctance of PS Core).

The Manufacture shall carryout Lighting Impulse Test & Temperature Rise Tests on One random selected CT of each Lot of 25 Nos. of every Item. In case, the Lot size is less than 25 Nos., then also it shall be mandatory to conduct aforesaid Test on One sample from such Lot.

In case the Manufacture does not have In-House Facility for carrying out Lightening Impulse Test then same can be carried out at other Facility (i.e NABL Accredited Lab), in presence of MSETCL's Representative.

All expenditure for carrying out Lightening Impulse Test outside the Manufacturer's Work shall be borne by the Bidder including Charges (Inclusive of TA & DA) towards Deputation of MSETCL's Representative. In case the CT does not pass the Test successfully, the entire Lot will be rejected.
