## **Subject- Revision in clause & Format contents of e-Tender Document.**

E-tender No./ RFx No. 7000037051

Name of work: "Establishment of 18 Nos 22kV GIS Bays (12 Feeders, 2 Incomers, 2 PT bay and 2 Bus Section) at 220kV Colourchem S/s under EHV O&M Division Bhandup alongwith allied Civil works."

Estimated Cost: Rs.11,22,59,647.48/- including GST Tender Fees: Rs. 25000/-+ GST.

## "Please note the following modifications -

1) Clause no 61.1 of tender document of General Terms & Conditions is revised as below—The Contractor shall guarantee/warranty that the materials will be new and in accordance with the contract documents and will be free from defects in material and workmanship for a period of 12 months (i.e. 1{One} year) from the date of final acceptance of the entire scope of work/project by the Owner (for material other than GIS). However, for the transformers, the 10% PBG to the value of Transformers/ ICTs shall be furnished by manufacturer/supplier for 60 (sixty) months (i.e. 5 {five} years) from date of supply. In case of failure after the guarantee period but before the estimated life of equipment, punitive actions deem fit will be initiated.

The contractor shall provide Technical and Expert support for Design, Supply, Erection, testing and Commissioning of GIS equipments and for after sale support for GIS Switchgear in India & the defect liability for any defect including spares & services for 05 (five) years from the date of commissioning.

Any defect developed due to defective materials and/or workmanship during testing and commissioning / performance of the works executed or during the guarantee/warranty period shall be rectified or made good by the Contractor at his own cost. The Contractor's liability shall be limited to repair / replacement of any defective part in the equipment of his own manufacture or those of his sub-contractor and arising from faulty design, materials and/or workmanship. All costs for the repair and/or replacement of defective parts such as dismantling, re-erection, supply, transportation etc. shall be to the account of Contractor.

As OEM, we assure to provide support & services to (Bidder Name) for following quoted products till the contract completion period. We also hereby confirm that we would be responsible for the satisfactory working of all equipment purchased by us and the spares for the equipment shall be available for at least <u>05 years</u> (warranty period) from the date of supply of equipment. So, we, OEM, hereby undertake that all the

components/parts/software used in our products shall be original & new and no refurbished
/ duplicate / second hand components / parts / software are being used or shall be used in
future.

We, further confirm that our system will provide <u>05 years</u> of warranty against
manufacturing defect and will be repaired by our authorized repair center which is located
in part of India."
