- 4) To complete the formalities like furnishing of Performance Bank Guarantee in prescribed format enclosed in tender documents, within 30 days from the date of receipt of LOA so that the contract agreement can be finalized soon. Additionally, as cable manufacturer or the collaborator/ Parent Company/Principals shall furnish an additional performance guarantee for an amount of 10% (ten percent) of the cost of such cable system as per Undertaking submitted in the tender.
