With reference to e-Tender No. SP/T-0729/1025 [RFx. No. 7000038006] (3<sup>rd</sup> Call), advertised for Supply, Installation & Commissioning of  $\pm 300$  MVAR STATCOM along with 400kV AIS Bay at 400 kV Lonikand-II S/s under EHV PC O&M Zone, Pune it is to inform as under:

- 1) The reply to bidder's additional queries received is hereby uploaded in the RFx (File Path: **Amendment\_VI\_Attachments.zip/Clarifications & Amendments**). Further, the replies already tendered in the subject tender and previous calls are also uploaded in the said folder for ready reference.
- 2) The bidders to note that as already indicated at Cl. No. 6.3 of Section-I of Book-I (GTC), the BSD will be valid for a period of 12 months from the date of opening of Techno-Commercial bid and shall have a further claim period of 12 months from date of expiry of validity. The same is also mentioned at sr. no. 4 of notes of Schedule-D '*validity of new EMD Bank Guarantee should be minimum 1 year from the date of bank guarantee prepared with further 12 months of claim period.*' However, the claim period in the format of bid security deposit / earnest money deposit – Schedule D of GTC Book-I is erroneously indicated as 8 months. Accordingly, the prescribed format of bid security deposit / earnest money deposit – Schedule D stands corrected and the revised Schedule-D is hereby uploaded in the RFx (File Path: **Amendment\_VI\_Attachments.zip/Schedule\_D\_GTC\_Rev.pdf**).

- 3) The bidders to note that alongwith their bid/ offer, the bidder is also required to submit Qualifying requirement data in prescribed format **Qualifying Requirement Information.xls** and Bid Forms alongwith attachments as per guidelines in **Bid Forms & Attachment.xls** hereby uploaded in the RFX (**File Path: Amendment\_VI\_Attachments.zip**).

All participant bidders are requested to take note of the above and submit their bids accordingly. All other terms and conditions of the Tender specifications remain unchanged.
