In connection with the above subject and the tender invited by Maharashtra State Electricity Transmission Co. Ltd. (MSETCL), we are pleased to inform you that MSETCL intends to accept your offer for the turnkey works contract for establishment of 220/33 kV Vilholi GIS Substation, along with associated transmission line, Dist.-Nashik under Nashik Zone, MSETCL Maharashtra against SRM E-tender T-2551 (RFx No. 6000001428).

- 1) Construction of 220kV DC line on DC towers by making LILO on 220kV Nashik (OCR) - Raymond S/C line at proposed 220/33kV Vilholi GIS s/s – 1.978 km
- 2) Establishment of 220/33 kV Vilholi GIS Substation:
 - a) 2 x 50 MVA, 220/33 kV Power Transformers with HV & LV GIS bays.
 - b) 2 x 220 kV GIS line bays at proposed 220kV Vilholi S/s
 - c) 1 x 220 kV GIS Bus Coupler
 - d) 2 x 220 kV PT GIS bay
 - e) 6 x 33 kV GIS outlets (Outlets to be constructed as per DISCOM requirement)
 - f) 1 x 33 kV GIS Bus Sectionalizer
 - g) 2 x 33 kV PT GIS bay
 - h) 2 x 200kVA, 33/0.4 kV Station Transformer

It may please be noted that the scope shall also include supply, ETC & Civil of all equipment/materials which are not specifically indicated in your offer but are necessary in order to meet the requirements of the work as per tender specifications in all respects.

3) Time for Completion:

The above work has to be completed within **15 months** from the date of handing over of site/line profile **(Including Monsoon) i.e. 12.01.2026**. Accordingly, it is requested to take handing over of site/line profile from the Superintending Engineer, EHV Projects Circle, Nashik.

4) GIS MAF Details:

It is requested to supply the 220/33 kV GIS equipments from M/s Siemens Energy India Ltd.

5) Terms & Conditions:

The detailed terms and conditions will be as per the tender specification, amendments thereof, your offer, clarifications thereon and notification of award & contract agreement being executed shortly.

You are requested to,

A. Within 10 (Ten) days from the date of receipt of this Letter of Intent:

- 1) Submit unconditional Letter of Acceptance to MSETCL against above LOI and after that Letter of Award will be issued.
- 2) Convey confirmation of acceptance of the Special Terms and Conditions (STC), if any, applicable to the contract.

B. Within 30 (Thirty) days from the date of receipt of this Letter of Intent:

- 1) Furnish the Contract Performance Bank Guarantee (CPBG) irrevocable and unconditional for the due performance of the Contract, for an amount equivalent to Ten percent (10%) of the Contract Price in the prescribed format.

- 4) Finalize the Master Network (MNW) Schedule and L-2 Network Schedule in consultation with MSETCL in accordance with Clause 30.2 of the GTC.
- 5) Detailed Bar Chart & L-3 Schedule, is to be submitted to the Superintending Engineer, EHV Projects Circle, Nashik, for execution & weekly review thereof.
- 6) To execute the Contract Agreement within 30 days after completion of all the formalities cited at Sr. No. (1) to (5).

Please note that non-compliance with any of the aforementioned conditions within the prescribed time frame shall result in initiation of termination of the Letter of Intent (LOI) on the 45th day from the date of its receipt.
