

- 2) Furnish Execution Support Bank Guarantee for an amount of 10% (Ten) of the ex-works cost of such GIS equipment. Refer IFB clause 3.2.6.
- 3) Furnish Performance Bank Guarantee(s), as applicable: against Cl. No. 17.1 of Book-I GTC.
- 4) Finalize the Master Network (MNW) Schedule and L-2 Network Schedule in consultation with MSETCL in accordance with Clause 30.2 of the GTC.
- 5) Detailed Bar Chart & L-3 Schedule, is to be submitted to the Superintending Engineer, EHV Projects Circle, Nashik, for execution & weekly review thereof.
- 6) To execute the Contract Agreement within 30 days after completion of all the formalities cited at Sr. No. (1) to (5).
