

**Notification**

**Sub.:** Online submission of Green application for grant of Open Access for Medium/Long term Open Access on revamped Green Open Access Registry (GOAR) from 01.01.2026.

NLDC had launched Green Open Access Registry (GOAR) for processing of Green Energy Medium Term Open Access (MTOA)/Long Term Open Access (LTOA) and Short (STOA) Term Open Access. STU is the Nodal agency for MTOA/LTOA and MSLDC is Nodal agency for STOA applications. However due to difficulties faced by consumers to apply on GOAR portal, all applicants seeking MTOA / LTOA from Renewable energy (Green) from Nodal Agency (STU) were applying on STU-Open Access portal as an interim procedure till the development of NLDC GOAR portal.

Now, NLDC has launched the revamped version of Green Open Access Registry (GOAR) portal on 15.12.2025.

Following are the instructions to the applicants seeking MTOA/LTOA where STU is the Nodal agency:

1. All the applicants seeking Green energy Open Access (MTOA/LTOA) with Green attribute (i.e Generator cannot sell REC Component separately) need to apply on Green Open Access Registry (GOAR) portal developed by NLDC and the link is available on Maharashtra STU website from **01.01.2026** onwards.

2. All the applicants seeking MTOA/LTOA Non- Renewable energy /Non- Green connected to EHV level shall continue on Open access portal available on Maharashtra STU website.

3. All the consumers to apply LTOA six months prior to the start date of Open access and MTOA three months prior to the start date of Open access.
4. The Application shall be accompanied by non-refundable processing fees of Rupees Two Lakh for LTOA and Rupees One Lakh for MTOA per application.
